INFORMATIVE REPORT ON THE PROCESSING OF PERSONAL DATA

The Regulation (EU) 2016/679 "General Regulation on Personal data Protection" (from now on "GDPR") states the right of any person to the protection of personal data that concerns that person. As an interested party, pursuant to Article 13 of GDPR, we provide you the following information.
